Minutes of the Meeting

Item 1 : IQAC Coordinator appraised on the activities envisaged under IQAC since its Sixteenth meeting on 19-06-2017 and Chairperson requested the members to approve minutes of its previous meeting. The following are the action taken correspondingly.

- Formulation of steering committee at institute level to prepare for NAAC cycle-2 accreditation.
- Institute level and department level meetings were conducted to create awareness on NAAC accreditation
- Submission of AQAR for the academic year 2016-17.

Item 2 : Chairperson discussed on the implementation of SVEC-16 regulations, he also requested to provide him with feedback on the current regulations to him in person.

Item 3 : NBA Accreditation expert team visited Institution from 11th-13th August 2017, to accredit UG programs, B.Tech.-ECE, IT, CE and CSE. Chairperson appraised on the experiences by the departments and it was accepted by its members to implement the practices suggested by NBA Expert team.



As part of NBA accreditation for non-accredited/newly accrediting departments like EEE, CSSE and ME, it is decided to submit applications for NBA accreditation in the academic year 2017-18.

Item 5 : NAAC accreditation awareness program shall be conducted on 22-09-2017 by Chairperson IQAC and Dr.I.Sudarsan Kumar, Professor, SVEC.

The time-line for submission of NAAC IIQA&SSR application starts in November 2017.
